Wood Chip Specifications

Wood Chip Product

Size	Consistent size of <u>2-1/2" x 2-1/2" x 5/8"</u> or smaller, allowing efficient movement through augers and mechanical systems. No extensive “stringy” wood chips (longer than permitted).
Screening	Screened to ensure the size requirements above.
Moisture	Consistent 35% to 45% moisture content (wet basis). <u>No chips with excessive moisture</u> (rain, snow, ice, etc.).
Type	<u>Hardwood only</u> , to ensure highest heat (BTU) content. Sugar maple, oak, beech, and yellow birch are preferred. No softwoods.
Cleanliness	Free of dirt, rocks, metal, paints, and all other foreign materials.
Estimated Volume	CVU estimates they will use approximately 1000 tons per year.

Wood Chip Delivery

Legal	Meet all appropriate legal transport requirements, local and federal state. Local contact is Michael Anthony – Town of Hinesburg, Highway Department.
Unloading	Unloaded by <u>self-unloading</u> equipment (i.e., self-unloading van). Unloading must be done in a clean manner, without excessive spillage of wood chips outside of the storage area.
Hours	Delivery to be prior to regular school hours, 5:00 am to 7:00pm, unless otherwise noted below.
Weigh Slips	Weigh slips are required/unless other arrangements are made with the school.
